

## **Mark My Word Acoustical and Tackable Panel Suggested Architectural Specifications**

Acoustical panels shall be **Mark My Word Acoustical Panels** as provided by The Mat King, 740 West End Avenue; Suite 1, New York NY, 10025 USA Telephone 800-442-6544.

Prefinished, factory assembled **Mark My Word Acoustical Panels** by The Mat King shall consist of a \_\_\_\_inch thick, \_\_\_\_\_pound density molded fiberglass core.

**Mark My Word Acoustical Panel** components shall have a Class "A" Flame Spread ratings of 25 or less as determined by ASTM-E-84 Tunnel Test.

**Mark My Word Acoustical Panels** shall have a minimum NRC rating of 0.55 - 0.65 when tested in accordance with ASTM-C423-81, based on test mounting "A".

In addition, photocopies of the test results from an accredited testing laboratory shall be submitted to the specifier/owner to substantiate that the sound reduction frequencies conform to the criteria as outlined in this specification.

The covering specified shall be PATTERN: \_\_\_\_\_, COLORWAY: \_\_\_\_\_. The fabric and/or #5 perforated vinyl wall covering shall be bonded directly to the panel surface wrapped and adhered to the sides and back of the panel. Fabrication procedures will ensure an aesthetically pleasing surface finish.

The appropriate hardware as determined most suitable by the manufacturer shall be mounted on the back of the panel unless otherwise selected by specifier.

The manufacturer shall submit sample panel(s) in the specified fabric or vinyl wall covering illustrating the edge detail and thickness specified, through either the contractor or the manufacturing plant. Manufacturing of panels will not commence without the written approval by the specifier. Shop drawings are available upon request.

**SHIPMENT:** To avoid damage in transit, panels must be packaged in 275 lb. test double walled corrugated cardboard carton, total weight not to exceed 150 pounds.

**INSTALLATION:** The contractor shall furnish all labor, materials, services and equipment necessary for, and reasonably incidental to, the installation of the **Mark My Word Acoustical Panels** as shown on drawings and as specified herein.

**WARRANTY:** All panel and baffle materials provided and installed within the manufacturer's standards for installation shall be warranted for a period of one (1) year from date of sale against defects to material or specified performance.
